Board Resolution CPA2024-00001, Hanover County Board of Supervisors

WHEREAS the Planning Commission is required by Virginia Code Section 15.2-2223 to prepare and recommend a Comprehensive Plan for the physical development of the territory within its jurisdiction and Virginia Code Section 15.2-2229 prescribes procedures for amendment of an adopted Plan; and

WHEREAS the Hanover County Board of Supervisors adopted a Plan on June 28, 1972, and amended the Plan periodically from 1982 through 2023; and

WHEREAS on June 26, 2024, the Board of Supervisors directed the Planning Commission to submit Comprehensive Plan Amendment CPA2024-00001 to public hearing; and

WHEREAS on July 18, 2024, following an advertised public hearing and consideration of information provided by the staff and public comment, the Planning Commission reviewed the proposed amendment and recommended APPROVAL of Comprehensive Plan Amendment CPA2024-00001, an amendment to remove three concept roads (Woodside Lane Parallel Road, Woodside Lane Extension, and Jamestown Road Extension) from the Major Thoroughfare Plan, along with related references to these proposed roads within the plan text; and

WHEREAS on August 28, 2024, the Board of Supervisors held an advertised public hearing to receive public comment regarding Comprehensive Plan Amendment, CPA2024-00001.

NOW, THEREFORE, BE IT RESOLVED by the Hanover County Board of Supervisors that Comprehensive Plan Amendment, CPA2024-00001, is hereby ADOPTED as an amendment to the adopted Hanover Comprehensive Plan, 2023 (Major Thoroughfare Plan), removing references to three concept roads (Woodside Lane Parallel Road, Woodside Lane Extension, and Jamestown Road Extension) from maps and text, with such roads shown within the Ashland Magisterial District and Beaverdam Magisterial District.

On motion of Mr. Stoneman seconded by Mr. Hudson, the members of the Board of Supervisors voted to APPROVE CPA2024-00001, as follows:












Concept Road

- Provides additional option for access to Economic Development Zone (EDZ) while avoiding existing residential development
- Connects to existing concept roads proposed as part of previous plans
- Added with 2023 plan





Concept Roads

- Connect Woodside Lane/ Jamestown Road to Hickory Hill Road/Old Ridge Road
- No longer necessary/ practical with Tract development

Attachment #2: Redline Text

FOCUS CORRIDORS

As part of the planning process, traffic volumes were analyzed based upon existing conditions and potential future conditions in 2045 (as shown on the General Land Use Plan). Traffic volumes were compared to anticipated capacity (how much traffic a particular roadway type can typically handle). Additionally, VDOT's Potential Safety Improvement Tool (PSI) was used to identify roadways and intersections where there are safety issues. Based upon this analysis, the corridors listed below should be the focus of transportation improvements

through 2045. Rezoning requests and other land use proposals located along these corridors should be thoroughly reviewed and analyzed to identify potential transportation impacts and mitigating improvements. Along some of these corridors, specific road improvement projects are already funded and/or planned to address identified capacity and/or safety issues. The corridors are not listed in any particular order. A map showing these corridors is included within the Map Book.

CONCEPT ROADS (PROPOSED THOROUGHFARES)

The MTP identifies concept roads, which are proposed major thoroughfares that, once built, are intended to:

- Create an interconnected road network that offers motorists multiple alternative routes to destinations;
- o Provide congestion relief by creating alternative routes parallel to existing roadways experiencing capacity issues; and/or
- o Improve access to Economic Development Zones (EDZs).

Concept roads shown on the MTP include:

- o Elmont Road/Vaughan Drive Connector
- o Lakeridge Parkway Extension
- o Lewistown Road Extension
- o Sliding Hill Road/Cedar Lane Connector
- Woodside Lane Extension
- Woodside Lane Parallel Road
- Jamestewn Read Extension
- Bell Creek Road/Academy Drive/Shady Grove Road Connector

- o Creighton Parkway
- Connector Road at Future I-95 Interchange (North of Ashland)
- Richfood Road Extension

Detailed alignment studies have not been completed for all of these proposed roadways, so the MTP typically only shows a general alignment. Future studies could further define the specific route of each concept road. As development occurs, right-of-way should be reserved for these future roadways.

Note that the proposed Woodside Lane Parallel Read would be located on County-owned property, but is within the limits of the Town of Ashland. A joint Town/County study should be conducted to understand how this potential connection could impact traffic operations and safety in the area. If built, the design and final location of this road would have to be coordinated with the Town of Ashland.
